Chairman's Letter

Last month I mentioned the serious problem of water shortage and President Macron's plan to address the problem. Apparently most of the water loss, 50%, is through leakages. He has set aside a budget to address the problem. Most of the focus is on the public saving water but in fact as only 20% of water is used by households there will be restrictions on industrial and agricultural use .

As this is the last newsletter before the AGM I want to focus on the volunteers that have helped to keep the association going and to pay tribute to them for the service they have given to Members. Over the last months I have asked Network coordinators to take on a bigger role than arranging their coffee mornings, important as those are, by organising activities and Network events, the latter to be open to all members. Your Committee, all volunteers, has been very active in the association. Philip Davies, who is treasurer and also manages membership, has been instrumental in introducing the Committee to GVO where all our documents are

electronically stored and can conveniently be accessed by any Committee member. Peter Holdway, secretary, who has administered bookings and the website, has worked closely with Phillip on this project. Alastair Ross took on Welfare, reports regularly and has spent many hours dealing with cases. Sandie Docherty, who has developed the Publicity role, adds all events and activities on the website in addition to ensuring they are published in the Newsletter, whose layout she designs in tandem with the editor. This is in addition to her network Coordinator's role, Johanna Matthews, Wellbeing secretary, is extremely active, arranging wellbeing activities, events and Seminars as well as organising Network events in her role as a Network coordinator. Pauline Holloway as the Network Organiser and a coordinator visits the coffee mornings to encourage discussion on activities and events for the Network, as well as helping with welfare. Although Tom Wilson, the only one still employed, has limited time, he has responded enquires generated from the website, added information to Facebook and has been leading a working group developing our personal safety and inclusion policy. Committee members spend many hours on your behalf and their dedication should be recognised. I trust many members will show their appreciation by attending the AGM.

Outside of the Committee there are other dedicated workers, notably our Newsletter editor Shirley Rowson, who, with Sandie, produces a professional quality edition each month. Shirley organises a monthly boules game for her network. John Oxford organises Monday Boules each week with the help of Robert Flanagan, David Berlin, Peter Holdway and Johan Nielsen who organise lunch in the various villages. There are others who lead activities, help out at events and support those responsible for them and I thank them all on your behalf.

In the area of **Charitable Giving** our last donation of this committee year has been to pay most of the cost of a Portacabin the Croix Rouge in Fréjus urgently required to house materials for those needing help with such everyday items as books and school supplies, toys and various childcare items.

Wellbeing; There will be a wellbeing seminar on Arthritis on 27 September in St Raphael, 18.00 to 20.00.

Networks: At the second Network coordinators' meeting, where guidelines for the organisation of coffee mornings, activities and events were updated, coordinators from Fayence, St Maximin, Cotignac and Villecroze outlined several of their planned events. There are two events in June, in addition to the regular coffee mornings. They are the Fayence network' Quiz and lunch by Lac de St Cassien on the D37 (not Tanneron village) Thursday 22nd June , which you might still be able to join. On 27th June a Picnic in the Park is planned in the attractive village of Villecroze, organised by the local network. The picnic will be followed by a tour of the grottes, an intriguing series of dwellings in the rock face adjoining the park. As it was thought that it would be too hot for a rally in July this event by the Cotignac Network has been postponed. For the same reason, and because of holiday plans, there are no new events in July and August but two networks have events planned for September.

Food waste recycling

Local authorities in France must provide all households with a means of keeping their food waste apart from other rubbish by January 1 next year. That means a bin - either individual or collective - to keep food waste separate from glass, packaging and general waste. It is part of a drive to help the environment by using food waste for fuel or compost instead of burning or burying it at landfill sites. The French government says 10 million tonnes of food is wasted or lost each year, costing €16 billion. Each person in France throws away around 30kg of food per year, according to France's ecological ministry, including 7kg still in its Almost all food waste could go in collection bins, including meat and fish, as it is used to create methane for France's gas network.

How can I reduce food waste?

- __Avoid buying too much: Plan meals a week ahead so you know what you need to purchase and how much of it.
- Look in the fridge and cupboards before you go shopping to avoid buying something twice.

- When you go shopping make a list and stick to it. Resist promotional offers as they encourage you to buy more than you need.
- Keep leftovers refrigerated and stored in transparent containers so it is harder to forget what you still have to consume.
- Be vigilant about expiry dates. Freeze meat and fish that will not be cooked within two days of purchase.
- Know which fruits should be placed in the refrigerator and which can stay on the counter and ripen.
- Collect dry bread or crusts if no one wants them. You can make croutons or breadcrumbs. Bread pudding is also a delicious way to use up leftover bread.

French tax inspections

Checks by tax officials into people's financial affairs resulted in an extra €7.8billion for state coffers in 2020. Maximising tax revenues is now seen as more important than ever, meaning check-ups are increasing. Everyone living in France must make a declaration of their worldwide income, though tax treaties help avoid double taxation. Non-residents with French income, such as from renting out property, must also declare this income. Failure to do so could result in checks - and fines.

Here are eight points to bear in mind to make a contrôle fiscal less likely:

1. <u>Declare all your overseas bank accounts</u> (this is for residents)

Make sure you declare all your overseas bank accounts (and do not merely declare the income from them). Not doing so can incur a €1,500 fine per account, or even more in certain states with no agreement with France on combating fraud. This does not include the major English-speaking states. You must declare 'neo bank' online accounts and accounts for cryptocurrency. Check where such accounts and platforms are based -French accounts should be known to officials, but all foreign ones must be declared by you. Bear in mind that the cross-border sharing of information is common now. If you opened accounts in previous years, it is advisable to own up to them, as tax offices are likely to be more tolerant of genuine mistakes admitted to them than where they discover accounts themselves.

2. <u>Declare any unusual change in income carefully</u>

If your affairs are simple and your income regular, there is no particular reason for a check but unexpected ups and downs from year to year can attract interest. So, ensure you declare any wind falls properly in case of having to explain yourself.

3. Be transparent about rental income

The tax office might also look out for inconsistencies between property ownership and incomes. For example, someone declaring a lot of rental income might be checked to see if they should have been declaring for property wealth tax.

4. Know the limits of gift tax

Financial dealings between family members are also sometimes a red flag. For example, take care in the case of large loans, which could be seen as a disguised gift. All large gifts, outside normal



presents, can be taxable under droits de donation. If you lend €5,000 or more in a given year, including in several amounts or to different people, you are expected to declare this loan to the tax office, if the recipient has not done so. If you receive loans of €5,000 or more in a given year, you should also declare.

5. Pension alimentaire only for 'essential' needs

Similarly, watch out for pensions alimentaires – financial support to family members in need, which can allow for a tax break if you declare the support in your tax declaration. Such sums should only be made under this pension alimentaire heading – as opposed to being a potential taxable gift – if they are to help with 'essential' needs. Substantial sums given to a child who is already self-supporting – for example, if he or she has an income equivalent to the minimum wage (Smic) – are likely to be seen by the tax office as breaking this rule.

6. Attention with nue-propriété within families

Another situation is where parents have made an arrangement to reduce liability to inheritance tax by giving the nue-propriété (residual ownership) of their home to their children while they maintain the usufruit (lifetime use). The children should not live in the home for extended periods unless a full rent is paid, as otherwise it can be seen as a disguised full gift of the home.

7. Make sure your income matches your lifestyle

People whose train de vie – lifestyle – does not seem in keeping with the income they declare might also be targeted. Reportedly, tax officers read the local press to see if people are talking about activities that suggest sources of income they have not declared. They are also allowed to look at social media and sites such as leboncoin

and Airbnb, though only for information shared publicly. Online platforms will share details of earnings on them with the tax office if they are above €3,000/year. Most letting is declarable income, as is buying (or making) and selling, though in most cases not if selling your own used goods.

8. Evaluate your financial and real estate assets

If you are an IFI wealth taxpayer, take care to give a 'reasonable' market valuation of your holdings. Increasingly, tax offices are making checks, especially when properties are passed on or sold, to see if they have been valued realistically. If necessary, it might be better to admit to a 'mistake' in the past and pay extra tax.

Timbre fiscal:

Everything you need to know about France's finance stamps

In France, you can buy a very particular kind of stamp to cover the cost of a titre de séjour, or French passport, to pay your taxes, get an ID card if you're eligible, or pay for your driving licence. Basically a timbre fiscale is a way of paying a fee to the government, and some online processes such as the tax offices - now have the more modern method of a bank transfer or card payment. However there are plenty of official tasks that still demand a timbre fiscale. In the preinternet days, this was a way of sending money safely and securely to the government and involved an actual physical stamp - you bought stamps to the value of the money you owned, stuck them onto a card and posted them to government office. They could be used for anything from paying your taxes to fees for administrative processes like getting a new passport or residency card.

These days the stamps are digital. You will receive, instead, either a pdf document with a QR code that can be scanned from a phone or tablet, or an SMS with a unique 16-digit figure. Both will be accepted by the agency you are dealing with. Once you have the code you need, you can add this to any online process that requires timbre fiscaux (the plural) and that will complete your dossier. You can buy them from a properly equipped tabac, at your nearest trésorerie, or online. Paper stamps remain available in France's overseas départements, but have been gradually phased out in mainland France.
